- 2. In this Privacy Policy, unless the context requires a different interpretation:
 - a. the singular includes the plural and vice versa;
 - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this Privacy Policy;
 - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
 - d. "including" is understood to mean "including without limitation";
 - e. reference to any statutory provision includes any modification or amendment of it;
 - f. the headings and sub-headings do not form part of this Privacy Policy.

- 3. This Privacy Policy applies only to the actions of Friendly Faces Disability Support CIC and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

How We Collect Data

- 6. We collect Data in the following ways:
 - **a.** data is given to us by you; and
 - **b.** data is collected automatically.

Data That is Given to Us by You

- 7. Friendly Faces Disability Support CIC will collect your Data in a number of ways, for example:
 - **a.** when you contact us through the Website, by telephone, post, e-mail or through any other means;
 - **b.** when you register with us and set up an account to receive our products/services;

in each case, in accordance with this Privacy Policy.

Data That is Collected Automatically

- 8. To the extent that you access the Website, we will collect your Data automatically, for example:
 - **a.** we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.

Our Use of Data

- 11. When you register with us and set up an account to receive our services, the legal basis for this processing is the performance of a contract between you and us and/or taking steps, at your request, to enter into such a contract.

Who We Share Data With

- 12. We may share your Data with the following groups of people for the following reasons:

 - third party service providers who provide services to us which require the processing of personal data to help third party providers in receipt of any data to perform functions on our behalf to help ensure the service runs smoothly;

in each case, in accordance with this Privacy Policy.

Keeping Data Secure

- 13. We will use technical and organisational measures to safeguard your Data, for example:
 - a. access to your account is controlled by a password and a user name that is unique to you.
 - b. we store your Data on secure servers.

- 15. Your Rights

- 18. You have the following rights in relation to your Data:
 - a. **Right to access** the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
 - b. **Right to correct** the right to have your Data rectified if it is inaccurate or incomplete.
 - c. **Right to erase** the right to request that we delete or remove your Data from our systems.
 - d. **Right to restrict our use of your Data** the right to "block" us from using your Data or limit the way in which we can use it.
 - e. Right to data portability the right to request that we move, copy or transfer your Data.
 - f. **Right to object** the right to object to our use of your Data including where we use it for our legitimate interests.

Changes of Business Ownership and Control

- 27. If any court or competent authority finds that any provision of this Privacy Policy (or part of any provision) is invalid, illegal or unenforceable, that provision or part-provision will, to the extent required, be deemed to be deleted, and the validity and enforceability of the other provisions of this Privacy Policy will not be affected.
- 28. Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.
- 29. This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
